#### **YACC By-Laws**

#### Section 4: FIDUCIARY DUTIES & RESPONSIBILITIES OF THE BOARD

Chamber Board members are expected to contribute to the Chamber either monetarily or through volunteer service.

Participation should include at least 2 of the following 5 criteria:

- 1. Attend at least 8 events (CNN's, Business over Coffee, Luncheons, New Member Receptions, etc.) in a calendar year
- 2. Serve on at least one (1) committee
- 3. Assume a leadership role in a Leads Group
- 4. Volunteer at a minimum of two (2) Chamber events
- 5. Monetary sponsorship of \$100 or more for at least one (1) Chamber event (participation fees do not constitute sponsorships)

On-time payment of dues and other fees are required for a member to remain in good standing and retain a Board seat.

Directors are expected to regularly attend and arrive on time for board meetings, unless otherwise excused.

Should a member of the Board of Directors incur three (3) unexcused meeting absences in a calendar year, the Executive Board reserves the right to bring to the Board a vote on early termination of that member's seat.

#### Section 2: SELECTION AND ELECTION OF DIRECTORS

#### For Expiring Terms:

At the regular August Board meeting, the Chair shall appoint, subject to approval by the Board of Directors, a Nominating Committee consisting of three (3) active Chamber Board members whose terms are not expiring. The Nominating Committee shall be responsible for creating a posting for the Chamber website and an e-mail to be sent to the Chamber membership announcing that Board nominations are being accepted for Directors to serve three-year terms. The notice shall list qualifying criteria as follows:

- · Candidates must have been an active Chamber member, in good standing, for a minimum of one (1) year.
- A bio must be submitted to the Nominating Committee by the candidate, and shall include the following: List of involvement with and contributions to the Chamber, and reasons for seeking nomination.
- Candidates must agree to accept the responsibility of a directorship.

Members whose terms are expiring may be considered for a renewed term by submitting their names to the nominating committee, and are subject to the election process.
